



Little Mr. & Miss Dickens Participant Agreement

I agree to the following:

No Refunds.

DIVISIONAL AGES: I agree that I meet the criteria below for the age division I am entering.

Baby – Between the ages of 0 to 18 months on or before November 22, 2025.

Toddler – Between the ages of 19 to 36 months on or before November 22, 2025.

Little Miss – Between the ages of 37 to 48 months on or before November 22, 2025.

Jr. Miss – Between the ages of 49 to 60 months on or before November 22, 2025.

NON-COMPETE CLAUSE: I am of good health and moral character. I agree that I am not under contract with any person, firm or corporation in respect to my present title nor have I made any legal obligations that would prevent my appearance or participation in the Little Mr. & Miss Dickens events. I agree to participate in all scheduled activities for the pageant dates and cooperate with pageant staff and assigned chaperones.

ALCOHOL, DRUGS & TOBACCO CLAUSE: I will not consume alcoholic beverages at any age or publicly smoke (to include vaping) while wearing my sash during the pageant. I understand that the use of illegal drugs is strictly prohibited.

PERSONAL INJURY CLAUSE: The Claremore Main Street organization, its officers, directors, staff and sponsors are not responsible for personal injury to anyone or damage during the pageant. I understand that it is my responsibility to ensure I am medically capable of competing at Little Miss Dickens competition and that I will not hold CMS, it's officers, directors, staff and sponsors responsible for my medical bills.

JUDGING CLAUSE: I agree that the time, manner and method of judging shall be solely within the discretion of the Claremore Main Street organization and the decision of the judges will be final. Contestants will be scored from 5 to 10, 10 being highest

Score, in each area of competition. In case of a tie for the overall title for my division, I understand that the Lead Judge will break the tie. I understand that 3 Judges are the minimum requirement at the pageant for each category of competition to include optional events.

APPEARANCE RELEASE: I permit my photograph, likeness, voice recording, and name to be used without charge for publicity and commercial purposes. I understand that I may appear on television. I understand that if I am selected the winner I may be called on to do appearances for Claremore Main Street that are now in effect or that become in effect during my reign for no compensation, but will not be made to appear if too far from home to travel. I further understand that I will be called on to do appearances to promote the pageant next year. Compensation for meals, travel and/or accommodation is guaranteed. (Only will make appearances within a certain distance from home).

WINNER CLAUSE:

I acknowledge ownership by the Claremore Main Street Organization the validity or the name Tiny Tim's Little Miss Dickens, Tiny Miss Dickens, Petite Miss Dickens, Little Miss Dickens and Jr. Miss Dickens, that I will not jeopardize such property rights in any manner.

I understand that as a Little Mr. & Miss Dickens titleholder, misrepresentation of my title, in any way, shape or form is considered fraud and is grounds for immediate disqualification and termination of contract. In this event, all prizes, including crown and banner when applicable, will be returned in the condition it was received at the expense of the titleholder.

Failure of the winner to comply with the terms, restrictions, provisions, or obligations thereof, shall at the sole opinion of the Claremore Main Street pageant director, result in the disqualification, loss of title and the contestant's resignation. In such case the pageant will be awarded the crown, banner and all prizes, in the same condition in which it was received.

This contract/agreement is not negotiable. I understand that I may withdraw from the competition at any time. I understand that I will not for any reason or under no circumstances be entitled to any refund, whether whole or in part of my registration fee. I also understand that there will be a \$30.00 charge for any returned checks.
